The EPA Preparedness Unit has a variety of trainings and resources available to strengthen your safety and security programs.

Training

- **LEPC 101:** Covers Local Emergency Planning Committee (LEPC) roles, responsibilities, and activities as well as various EPA programs and regulations.
- **Chemical Facility Industry Workshops:** Geared for industry covered by EPA, OSHA, and DHS regulations, these half day workshops cover the Emergency Planning and Community Right to Know Act (EPCRA), Risk Management Program (RMP), oil programs including Spill Prevention Control and Countermeasure (SPCC) and Facility Response Plans (FRP), as well as OSHA and DHS programs.
- **Emergency Planning Tabletop:** A two-hour run through of a chlorine release where participants analyze a facility plan and a community emergency plan to identify gaps and strengths.
- **CAMEO: Computer Aided Management of Emergency Operations:** Offering up two days of instruction on the modeling and chemical analysis program.
- **TERA: The Emergency Response Application:** Offering instruction and demonstrations of this EPA mapping tool (available to government entities)
